The University reserves the right to cancel, add or reschedule events with ninety (90) days notice prior to the event, without penalty. The Contractor must attempt to accommodate rescheduled dates provided by the University, if any. In the event University provides less than ninety (90) days notice but more than thirty (30) notice, University will be obligated to pay 50% of the agreed to rent for that event. If the University cancels with less than thirty (days 30) days notice than the University will be obligated to pay the full amount to Contractor.

2.4.6 Audio visual equipment (including projector, screen, sound equipment).	GoodWorks Infinity Hartford provides all in-house hardware to UCONN Hartford at no cost to the university, it is included in our rental rates. Including in this is: ALL HOUSE SOUND AND LIGHTING, PROJECTOR, SCREEN. Additionally, we have 5 flat screen tvs which can discplay still images (slideshows, etc) Any additional requirements are quoted/rented on a case by case basis. Examples of this are lavalier or wireless microphones which can be rented for \$150 per unit.
2.4.7 Technical Support Staff	Depending on the complexity of the event, staff can range from 1-3 people. The cost is \$300 per person. Typical events have 1 or 2 required technical support staff.
2.4.8 Set-up (including podiums, flip charts and white board).	We have a podium which we provide at no charge. Any display other than what was previously stated is the responsibility of the the renter.
2.4.9 Wireless Guest Sign-In	We provide Wi-Fi access and the University is welcome to provide sign-in hardware. If venue staff is required to help it will be between \$150-\$250 per person depending on hours. In the past UCONN HARTFORD has provided their own registration.
2.4.10 Signage for Event	Any signage/display other than what was previously stated is the responsibility of the the renter.
2.4.11 Parking and Security	There is a parking lot adjacent to the venue managed by ProPark as well as second one across the street. Oversized vehicles can park at the Convention Center. Pricing is provided on a case by case basis and can be handled through Infinity Hall. GoodWorks Infinity Hartford provides on-site security and is quoted on a per event basis as each event is different. Typically, the cost is a minimum of \$150 (up to 200 people) and \$100 for each additional 100. Security pricing is subject to change based on the
